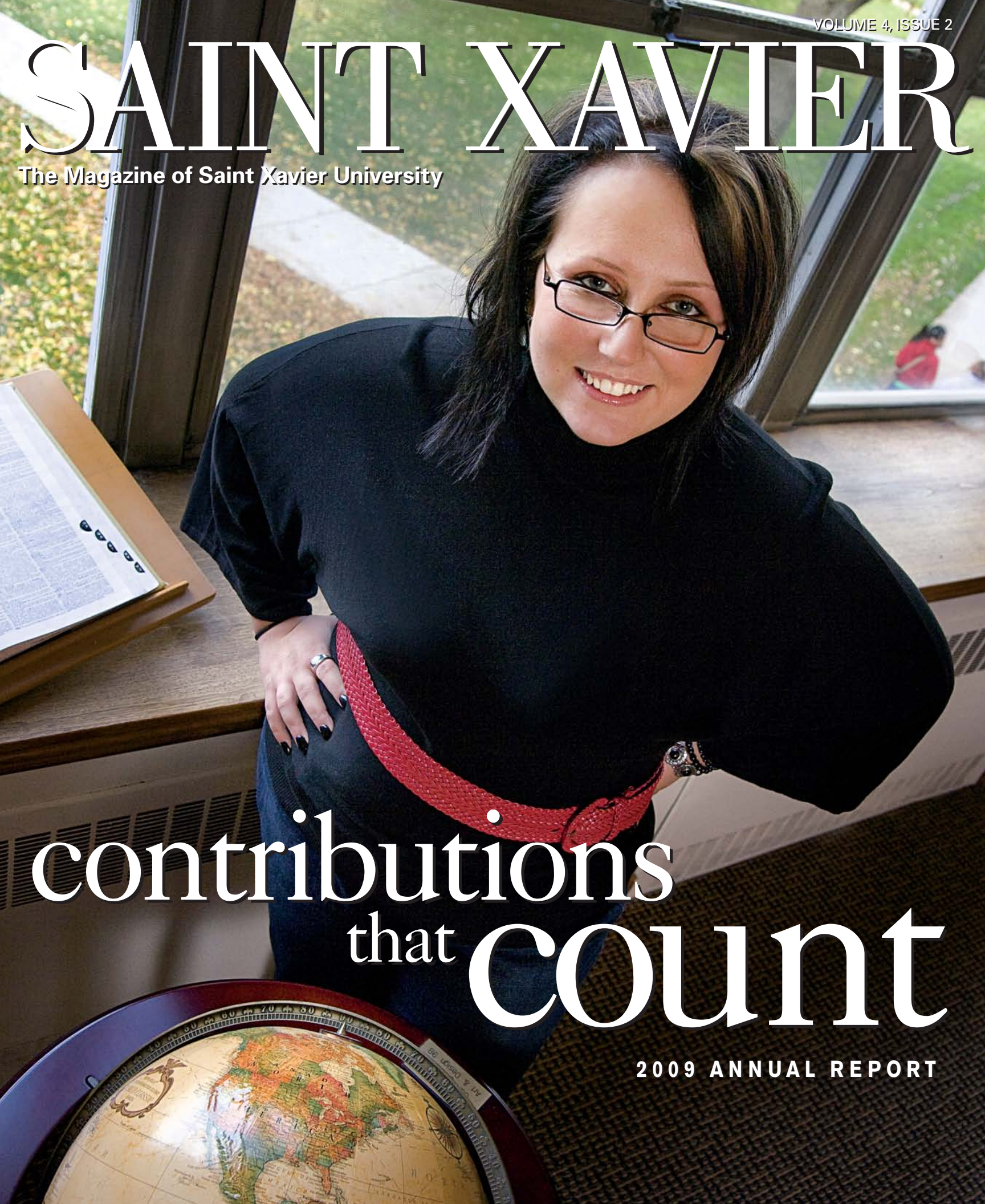

**Changing the world, one community at a time**

What does it mean to be a university?

The word itself is derived from the Latin universitas, meaning “whole,” “universe” or “society.” Its etymology could also include “community” and “people,” for what is a university if not a community? And what is a community if not the people who inhabit and inform it?

John Ziegler, a distinguished Saint Xavier philosophy professor who died in 1995, once observed that universities “are people that rise and fall with the caliber and considerateness of the people in them.”

How relevant that thought is today as we share the experiences of four Saint Xavier graduates who exemplify the University’s mission “to educate men and women to search for truth, to think critically, to communicate effectively, and to serve wisely and compassionately in support of human dignity and the common good.”

Bob McShane, Judith Parker Mastin, Jeff Kenny and Patrice Stephens represent thousands of community-minded alumni from the College of Arts and Sciences, the School of Education, the School of Nursing and the Graham School of Management.

SXU as a whole, faculty, staff, friends and spiritual and financial supporters, changed the lives of these former Saint Xavier students. Now, through the caliber and considerateness of their character, these alumni and many others like them are changing the lives of the people in communities both here and throughout the world.

**A Hidden Talent for Helping Others**

**Jeff Kenny '86 was the classic case of a young man having little idea what to do with his life. He bounced around several colleges before quitting school and getting married in 1982. Soon his wife was pregnant with the first of their four children. Then, in July 1983, an accident dramatically changed his life.**

“I was working at a meat-packing plant where 2,000 pigs a day were slaughtered,” recalls Kenny. “I helped take care of the equipment at night and made sure the cooling systems were working properly. One night we were repairing part of the refrigeration system when a valve blew up in my face. I was burned with hot ammonia gas and lost my sight instantly.”

Doctors told Kenny he would never see again.

“So I had no choice but to go back to school,” he says. “I chose Saint Xavier because it took the least number of buses to get to from where we were living at the time in Marquette Park. I loved being at school because now there weren’t any distractions. I was married and had a baby daughter. I knew I didn’t have any choice but to try to do good.”

In Kenny’s case, doing good might be an understatement.

After earning his sociology degree from Saint Xavier and a master’s in social service administration from the University of Chicago, Kenny spent the next two decades working as a psychotherapist. He dealt with cases ranging from teenage pregnancies and suicidal adolescents to domestic violence, first with Children’s Home and Aid Society in Chicago and then in his own practice.

Today, the bulk of Kenny’s energy goes into Hidden Talents, a nonprofit after-school program for sixth-, seventh- and eighth-graders he started in 1995 and runs out of Queen of Martyrs School on Central Park Avenue in Evergreen Park, Ill.



“After working with so many pregnant teenagers and suicidal teenagers I wanted to help kids prevent some of those problems instead of working with them as a therapist after the fact,” says Kenny. “So we started an art program and a theater program. Our first theater program involved 12 kids from Queen of Martyrs, and now we have about 80 kids from 12 or 13 grade schools in the area. We also have dance and voice lessons, cooking classes and contests, a running group and retreats involving about 150 kids altogether.

“The idea is to get to know the kids and help them on their way,” he continues. “We want to build kids’ self-esteem and give them an opportunity to meet kids they otherwise wouldn’t meet until high school. We’ve also brought spirituality into each of the programs, which is not so much about prayer but helping kids get to know who they are inside and what they were put here for.”

Kenny’s life was built around sports, those he participated in – he grew up in Burbank, Ill. and played football at St. Laurence High School – and those he attended when his kids were growing up. He came to realize that not everyone is an athlete, which often means exclusion from certain social circles.

“I wanted to provide something for kids who fell through the cracks, who weren’t great athletes, who didn’t like sports, who weren’t popular or part of the in-crowd,” he says.

Kenny’s years at Saint Xavier reset the course of his life almost as much as losing his sight.

“I had a sociology professor at Saint Xavier named Pat O’Brien who was a huge influence on me,” he says. “She was really into studying domestic violence and child abuse, and I was naïve about those kinds of issues before I came to Saint Xavier as a 21-year-old. It was a whole new world to me. So I started taking all of her classes.”

Kenny has been inextricably linked to the University community ever since. He moved his family to the Mount Greenwood, Ill. neighborhood from Hyde Park, Ill. after finishing his degree at the University of Chicago, and many of the Hidden Talents volunteers are Saint Xavier students.

“It’s really strange how it worked out, because Saint Xavier was such a vital part of getting back on my feet after my accident, and now so much of my life is right around here.”

Kenny and his wife, Lisa, talk about turning to missionary work in the future, possibly taking the model of his after-school programs abroad to India and Africa.

For now, his attempts to “do good” in his own community would seem to have no bounds. Two years ago, for instance, Kenny started using his former downtown condo office as a kitchen headquarters to prepare sandwiches for homeless men.

“Panera donates breads and desserts to us every Wednesday night, and then we either buy turkey or get a donation and make sandwiches,” he says. “We start near the Wrigley Building and cover a mile-and-half circuit, feeding 25 to 35 homeless guys on the street. The kids help out when they don’t have homework or anything going on with our programs.”

It’s all part of Kenny’s daily mission to help kids discover their hidden talents, and, as he says, do good.



**If Patrice Stephens '80, '86 were ever to doubt the impact she has on the people whose lives she touches every day, she would need only to open her gratitude box.**

"It's a box some of my younger patients put together for me," explains Stephens. "That's where I keep all the thank-you notes I get. And I do receive a lot of appreciation from my patients."

Stephens is a breast cancer specialist at Advocate Christ Medical Center in Oak Lawn, Ill. where she first started working as a nurse's aide during her undergraduate days at Saint Xavier.

"I'm what the hospital calls a 'navigator,'" says Stephens. "I walk a patient through that whole process, from diagnosis to surgery to therapy. I'm the patient's guide or mentor. I tell them my role involves education, resource and support and that I can spend as much time as I need to with them."

## Patrice Stephens

### A Navigator for Her Patients

Her nursing duties, for 20 years in the oncology unit and the past 10 as a breast cancer specialist, have taken Stephens far beyond the hospital walls, literally and figuratively. She tends to hundreds of patients every year, but the number of people she touches expands exponentially when she spreads her knowledge into the community.

"A big part of my role is to educate the community, and I'm fortunate that my role at Christ feeds right into that," she says.

At the hospital, Stephens co-leads a monthly breast-cancer support group, which participates in the American Cancer Society's Relay for Life, held every July in Oak Lawn.

"We've formed a team with women from the group and other survivors who want to give something back," says Stephens. "We call ourselves the Treasure Chests, and I'm the team captain. We also do a program through the hospital every October for Breast Cancer Awareness Month called Paint the Town Pink, when we bring in physicians and speakers to educate women."

Throughout the year, Stephens visits with women in community groups, schools and churches to educate about early detection, including the importance of mammography and self-exams.

Stephens has received several awards for her devotion to breast cancer patients and for her commitment to educating fellow nurses and the community in general, including the SXU School of Nursing's Academic Distinguished Alumni Award in 2003.

"I've received some wonderful accolades for doing what I love to do," says Stephens.

Nursing is the only thing Stephens has ever wanted to do.

"I don't know if it was from seeing nurses when I was 7 [years old] and in the hospital for pneumonia or whether I was influenced by my older sister, who became a nurse and was my first mentor," she says. "Whatever it was, I knew I had to be a nurse."

The School of Nursing only sealed the deal.

"The education I received at Saint Xavier was just a phenomenal experience," says Stephens. "I made a lot of lifelong friends and have worked with dozens of alumni at Christ, many who were classmates and some who have just completed their master's degrees. But what made the nursing program so special is that we were taught that it's an honor to be part of a patient's life, to be able to make an impact on someone's life."

Bonding with a patient and a patient's family, she says, is one of the great rewards of her profession.

"I had a patient pass away in June on my birthday, and I'm still very close to her husband, son and mother," Stephens says. "I had taken care of Michelle for the five or six years she struggled with her diagnosis. Her mom calls me frequently just to talk, maybe to hear Michelle's voice through me."

No doubt there's also a thank-you note from Michelle's mother in Stephens' gratitude box.

## Cohorts Set the Teaching Bar High

Just two years of teaching high school convinced Judith Parker Mastin M.A. Education '04 that she was not getting the most out of her time or her education. So she did something unconventional yet practical, she went back to middle school.

"I returned to my neighborhood school, Ashburn Elementary, to teach seventh- and eighth-graders," says Parker Mastin, who taught freshman English at Collins Academy High School in North Lawndale, Ill. for two years before returning last fall to Ashburn. "I was seeing too many kids woefully unprepared when they came to high school and felt that I could do more good, educationally and socially, with middle-school students. During my time at Collins, I figured out what was missing at the middle-school level in instruction. That made me want to go back to my neighborhood and make a difference."

Parker Mastin has been making a difference since 2004, her rookie year in teaching. Since then, she has become National Board Certified, joined the staff at Collins Academy, which is part of the Academy of Urban School Leadership, and in 2008 received the SXU School of Education's George K. McGuire Award. The annual honor recognizes an alumnus for distinguished service to the University and the field of education.

"It must have been a very thin list of candidates that year," laughs Parker Mastin. "The award really did surprise me. But I've been very lucky in my career. The things that have happened to me have been divinely ordered."

Parker Mastin, a mother of two teenagers, grew up in Chicago's Washington Heights neighborhood. After earning a degree in English from Chicago State, she enrolled in Saint Xavier's School of Education master's program.

"One reason was that Saint Xavier had the cohort model. The idea that you would go through your course study with the same group of people really interested me," says Parker Mastin. "It also gave me the impression that they're going to take a lot better care of us than other schools. The education department was so encouraging and accommodating when I applied that I didn't have an excuse not to enroll."

At Saint Xavier, Parker Mastin came to understand that kids today are different, a realization that continues to shape her attitude in the classroom.

"We now know so much more about the brain, how it works in learning and the social and emotional needs of children," she says. "Because of that, we can't teach the way we're taught, unless you had a teacher who was way ahead of her time. When I was in elementary school, my teachers believed in one size fits all. We all took the same tests, we all sat in rows, and we memorized information. Now you have to be innovative every day."

She also learned "that I'm a better teacher when I can communicate with other teachers, and I got that from Saint Xavier. My cohort members gave me ideas, they pushed me to be better, they kept me focused and excited about education. I established a rapport with some pretty driven women who set the bar high and kept it there."



Parker Mastin's strong views on education in the 21st century haven't always been greeted with applause from colleagues.

"I've gotten into a lot of debates about this with traditionalists who want kids to memorize a bunch of facts," she says. "We shouldn't teach for memorization. We should teach skills. Will kids be able to infer and draw conclusions and identify relationships and analyze situations because they memorized the name of the horse in *Animal Farm*? That seems pretty trivial in comparison. It won't help them read a contract, it won't help them choose the best rate for a home or car loan. And isn't that our purpose, to prepare kids, even as young as elementary school, to conduct themselves in a way that they're able to navigate their lives successfully?"

Her "holistic" approach to teaching seventh- and eighth-graders seems to be working for her right now. But she's also realistic about the increasing challenges and pressures that burn out even those teachers with "wild-eyed enthusiasm."

"When I first started teaching I came home very tired because it was physically and mentally exhausting. Anyone who goes into teaching has to get a health-club membership at the same time. It's a requirement," she laughs. "I don't want to teach because that's all I can do. When I stop being able to contribute and change lives, then I'll need to find something else."

‘Smart’ Business is Good Business

**In a few years, if all goes according to plan, Bob McShane’s B.A. ’89, MBA ’91 startup company, First Precision, will be smart, green and global.**

“Had it not been for my MBA out of the Graham School, I probably would not be doing what I’m doing,” says McShane. “Everything you do in the MBA program, from learning to write a good business plan to understanding how a pro forma goes forward to balance sheets and the myriad of other activities involved in business, have been invaluable in helping me achieve what I’ve done.”

The Evergreen Park, Ill. resident launched First Precision in 2004 to market a technology known as “PowderCoil,” and was granted a patent in December 2009. The device, which is being commercialized for the industrial steel and aluminum industry, coats steel and aluminum coils at high speed using powder paint.

“We’re confident it’s the future of pre-painted metals,” says McShane, the company’s owner and president.

Other people agree. McShane and First Precision won the 2007 Venture Idol contest in Indiana for innovative technology, and he received a grant in 2008 from the Indiana 21st Century Research and Technology Fund. That money has been used to lease a facility in Crown Point, Ind., and purchase equipment. The grant requires recipients to develop their businesses in the state of Indiana.

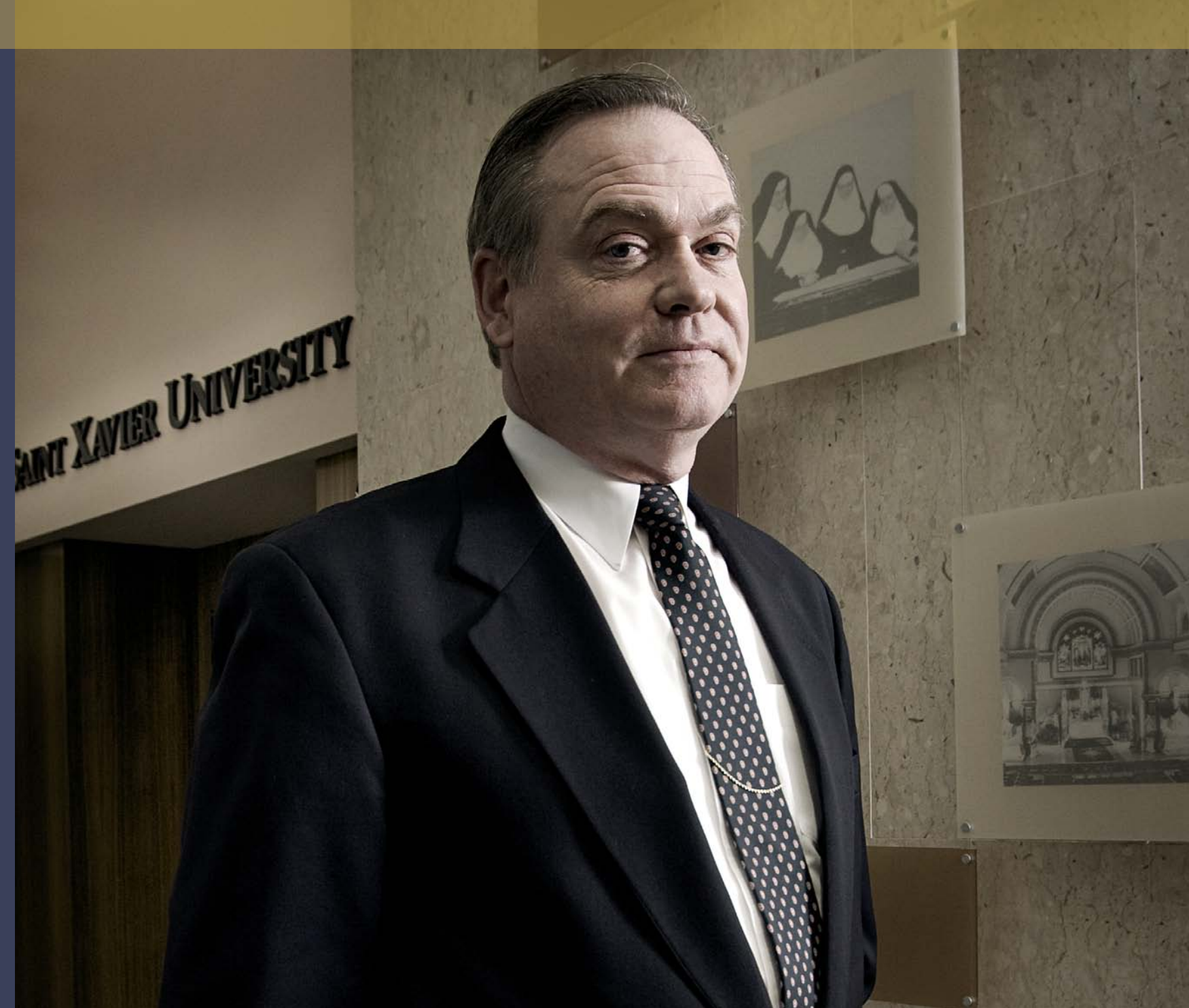
“The way the plan rolls forward we expect two things to happen,” explains McShane. “One, the plant will be up and running and producing material by the end of 2010. The second phase will involve our design and technology being licensed on a global basis. We’ll sell the license and the equipment that is used to run our technology. According to our pro forma in the first three years, we expect to be a \$23 million company.”

McShane also expects to set new industry standards in the categories of “smart” and “green” as First Precision targets what he calls the “big five” markets – building products, automotive, appliances, containers and metal furniture.

“We apply powdered paint to the surface of steel and aluminum coils with a brand-new technology that’s about as green as grass,” he says. “If you design a system, as we have, in which there is no air or water pollution, no CO2 admissions, it’s just a smart way to do business, a smart way to make products today.”

He suggests that his budding business is a breath of fresh air in another way.

“I’m a firm believer of developing manufacturing business within the U.S. economy,” he says. “The loss of manufacturing jobs in the United States is a tough pill to swallow. A lot of our ‘smartness’ has been transferred overseas where other folks have been able to apply technology, which we have, to produce whatever the widget might be on a lower cost basis.”



McShane plans to do his part to change that, even if only in a small way at First Precision, with a target labor base of 42 people.

“When I was in the Graham School, I learned that you can do what you want to do, you can succeed if you apply yourself,” he says. “It gave me confidence knowing that I had both the internal drive to make something happen and the intellectual property, which I’d acquired as a student at Saint Xavier.”

But that’s not to say he doesn’t experience sleepless nights as he deals with First Precision’s growing pains.

“There are so many issues and questions that come up when running a business and literally not enough hours in the day to solve them all,” says McShane. “So it helps to have someone or something to lean on. The Graham School provided me with the training that I still lean on today.”

## A Legacy: Keeping the Passion Alive

## SXU Receives Two Grants from the U.S. Department of Education

Saint Xavier University received two grants from the U.S. Department of Education Fund for the Improvement of Postsecondary Education (FIPSE) during the summer of 2009.

- The University will use a two-year, \$242,560 grant from FIPSE's College Course Materials Rental Initiative to implement a textbook rental program for 25 courses that are most commonly taken by freshmen and sophomores. Grant funds will be used to purchase approximately 2,100 rental books for the program. The rental fees collected over the two-year grant period will be used to continue adding courses to the program after the end of the grant, with the goal of developing a comprehensive undergraduate textbook rental program. Only a small percentage of colleges and universities in the United States offer textbook rental programs, yet rental programs can be an important resource for students with financial need, who may postpone buying textbooks, which can limit their ability to do well in their coursework.
- The University will use a two-year, \$256,490 grant awarded under FIPSE's Graduate Programs at Institutions Serving Hispanic Americans initiative to support Project Bilingual English-Spanish for Speech-Language Pathology (BEST for SLP). This project will develop interactive multimedia instructional materials and learning activities to enhance the instruction of graduate-level, bilingual (English-Spanish) speech-language pathology (SLP) students. Students trained with these materials will be linguistically and culturally prepared to work with pre-school and school-aged Hispanic children who have speech or language impairment or hearing loss that affects communication. There is a serious under-representation of Spanish-speaking SLPs in the United States, yet few universities offer course work that sufficiently prepares bilingual SLPs. The materials developed through this grant will be used by graduate speech pathology programs across the country in order to improve the preparation of bilingual graduate speech-language pathology students.

## A Growing Spirit of Philanthropy among Graduating Students

### The Class Gift program soared to new heights in 2009.

A committee representing spring and winter graduates of the Class of 2009 chose to raise money to help improve campus accessibility through the purchase of a wheelchair lift. Especially for use at Commencement, the lift would provide access to the stage for students with mobility issues. It was the committee's belief that each student, regardless of physical ability, should be able to cross the stage to accept his or her own diploma.

"I think we chose a very worthy project that links one of the University's needs to our mission and core values," said class gift committee member Jennifer Betcher '09. "Plus, the Class Gift is a terrific way for SXU graduates to give back to the University that provided them with so many opportunities and experiences to learn and grow not only as students but also as people."

The results of the fundraising efforts were record-breaking: 260 donors contributed more than \$9000 for the project. This marks a 15 percent increase in the total number of donors and a 17 percent increase in total dollars raised over the Class of 2008. What's more, the Class Gift program has experienced double-digit growth in donors and dollars every year for the last four years.

Included in the 2009 totals is a generous match from Trustee Patricia A. Morris, Ph.D., '83 and her husband, James A. Morris, for every dollar donated by students. Dr. and Mr. Morris have matched class gifts since the beginning of the program in 2001.

"It's wonderful to see, each year, an increasing number of students realizing the impact their giving can have on the Saint Xavier community, even with small gifts. Jim and I are hopeful this growing spirit of philanthropy will translate into a bright future for the University," said Dr. Morris.

## SXU receives ‘booster shot’ from VNA Foundation

Saint Xavier University’s health community outreach efforts received \$101,734 from the VNA Foundation (www.vnafoundation.net), to provide a part-time family nurse practitioner at the St. Margaret of Scotland Elementary School in the Washington Heights neighborhood of Chicago for two years. Like many urban Catholic elementary schools, St. Margaret’s did not have a dedicated nurse or health aide to manage student acute health needs and ensure compliance with state health requirements. The services provided to this population exceed those many would expect. By staffing the office with a family nurse practitioner, the office fills in medical services that many underserved families go without, such as assisting in the management of chronic conditions and identifying and treating acute health concerns. She also works with teachers to craft health education materials and with parents to inform them of healthy choices and opportunities. All in all, the project is increasing the health of the students and making it easier for them to focus on their job, learning.
