# 2008 annual report

Dear Alumni and Friends of Saint Xavier,

Saint Xavier University's dedication to success with purpose resulted in landmark achievements in 2008. We consider it a tremendous accomplishment that the University reached its fundraising goals for the third consecutive year. The University also takes great pride in the recognition of academic achievement. The fortitude and generosity of our faculty, alumni, Sisters of Mercy sponsors, trustees and other supporters consistently advances Saint Xavier University's mission and promotes an environment of academic excellence.


In June, we announced we had met a Mercy Challenge grant of \$1 million from 354 gifts and pledges, bringing the total endowment for our Office for Mission and Heritage to \$2.5 million. We increased our net revenue from the previous year for our Golf Classic and Scholarship Ball by 77 percent and 72 percent respectively. We exceeded our entire annual fundraising goal by 11.5 percent for a total of just above \$4 million.

Saint Xavier University has renewed a ten-year accreditation with the Higher Learning Commission as well as our membership in the North Central Association. The School of Nursing earned a national distinction as a Center of Excellence by the National League for Nursing, becoming one of only 15 schools to do so. The School of Education received re-accreditation from the Unit Accreditation Board of the National Council for Accreditation of Teacher Education at the initial teacher preparation level and accreditation at the advanced preparation level. In addition to these accomplishments, our Graham School of Management just celebrated its 10-year anniversary in a strategic educational partnership with the Chicago Police Department.

Over the summer we completed our second residence hall built to LEED Gold construction standards as put forth by the U.S. Green Building Council, Mother Agatha O'Brien Hall. This new residence hall brings us closer to achieving our strategic goal of providing residence for at least 1,000 students living on our Chicago campus.

Saint Xavier University continues to surpass goals and exceed expectations because our supporters demonstrate dedication to furthering the University's mission. Our friends and benefactors continue to be fundamental to the University's progress.

## a letter from the vice president for business and finance

Dear Friends,

I am pleased to share with you the University's financial statements for the year that ended June 30, 2008. Our auditors completed their financial review of the University and have rendered an unqualified opinion. The financial statements are presented in accordance with SFAS 117; contributions received are presented in accordance with SFAS 116; and accounting for investments is presented in accordance with SFAS 124.

On June 30, 2008, the University recorded a change in the net assets of \$1.9 million. The University's total gross assets were \$149.3 million. The fair market value of the University's investment portfolio, including beneficial interests in trusts, was \$11.9 million.

In June 2008, the University closed on \$25 million in adjustable rate demand revenue bonds, Series 2008, through the Illinois Finance Authority. The majority of the proceeds will be used to fund the construction of student housing.

In fall 2008, the University opened O'Brien Hall, a 37,000-gross-square-foot "green" residence hall. This is the second University facility to receive the Leadership in Energy & Environmental Design (LEED) gold designation. The University is the first institution of higher education in the state of Illinois to have two LEED gold designated facilities; one of two in the Midwest; and one of ten across the United States.
